MAY 18, 2016 BOARD MEETING RECAP

- Board ratified and approved the April 6, 2016 General Session Meeting Minutes and Architectural Report from 3/29/16-5/11/16.
- Board accepted the March 31, 2016 and April 30, 2016 financial statements as submitted.
- Board approved to send out the revised proposed view & tree trimming policy to the membership, giving the homeowners 30 days to comment, before it being adopted at the July meeting.
- Board postponed further discussion about possible changes to the Architectural Guidelines until the June 1, 2016 meeting, because there are sections missing in the proposed version and the guidelines need to be updated. The Board wants to also make sure that verbiage is included about side gates, no vinyl perimeter fencing and the review time allowed remain at 45 day and not be extended to 60 days.
- Board approved to take \$100,000.00 from the Association's checking account and invest it in an operating CD with Morgan Stanley for a term of 3 months, at the highest interest rate available.
- Board approved to grant a homeowner a variance for installing a vinyl
 fence in front of her house in the Sandstone color, that would match
 the vinyl fence that was approved and installed at the house next door.
- Board approved to renew the Association's insurance policies that expire on 6/1/16 with A/R/R, for a premium of \$9,843.00.
- Board approved proposals from Villa Park Landscape to thin/lace two Agonis trees, for a cost of \$220.00 and items generated from the 4/21/16 landscape drive, for a cost of \$2,402.50.
- Board postponed any work being done to the fence/gate by the water tower at Lindengrove/Diamondgate, so Management can obtain proposals to install a new aluminum fence/gate.

ANNUAL ELECTION OF THE BOARD OF DIRECTORS & AVCA DELEGATE
