## PARKING REMINDERS

- Inoperable vehicles may not be parked anywhere on the properties, except inside a garage with the door closed.
- No vehicle may be parked on the street for more than 96 hours.
- No vehicle may be parked in any manner which would block the sidewalk.
- Operation of off-road motorized vehicles is not permitted anywhere in Pacific Ridge.
- Vehicle repair or maintenance may only be performed inside a garage with the garage door closed.
- Trailers, boats, equipment and recreational vehicles may not be parked or stored anywhere in the properties where they are visible from any lot or portion of the public streets within the properties.
- Use or storage of flammable materials is prohibited except for normal home maintenance materials and such material normally found in a resident's motorized vehicle.
- Garage doors are to remain closed when not in use.

## WINDOWS REMINDER

- No windows shall be covered by paint, foil, sheets or similar items except within the first 90 days after close of escrow.
- No reflective or metallic window covering of any kind is permitted.

## TRASH REMINDER

- All trash must be securely tied or completely covered when set out onto the curb.
- Trash barrels/sacks must not be set out more than 12 hours prior to trash pick up, and must be removed from the curb not more than 12 hours after scheduled collection time.
- Trash containers must not be stored in any area visible from the street.
