# PRE-APPROVED EXTERIOR PAINT COLOR

The revised pre-approved exterior paint color schemes were approved by AVCA and the Board approved the action to mail out the notification for twenty-eight day comment period for a second time. If all goes according to plan, the exterior paint schemes will be formally adopted at the December 2, 2020 Board Meeting and Homeowners will be able to select a new, inspiringly beautiful, updated exterior paint scheme for their home and submit your architectural applications for review by the Pacific Ridge ARC.

It is understood that you may have questions in regard to the new pre-approved exterior paint colors and Management is here to help you with those questions.

# **Quick Clarifications:**

- Before making any final arrangements with your painter, please make sure you have completed the Pacific Ridge Community Association "Color Placement Diagram" so you understand approved paint schemes and where they are applicable.
- Front door colors include; <u>dark trim</u>, <u>light trim</u> or designated <u>front door color option</u> on each palette. \*Wood front doors approved on a case by case basis.
- Garage door colors include; <u>dark trim or light trim color</u> only on each palette.
  - Stucco Pop-out colors include; <u>Stucco Accent color</u> option on each palette and are only available to houses in the Palisades and Pinnacle.
- Always, visit the paint store to see "actual" colors. The digital schemes on the website can be deceiving. Also note; all Sherwin Williams paints can be matched at any other paint manufacturer you choose.

An architectural application is required to be submitted regardless of if you are painting your home the current existing color, or if you are selecting one of the new pre-approved color schemes. By submitting an architectural application, the Association's records are kept current with the date of your re-paint and the color scheme on your home and your neighbors home.
