The OCFA will be inspecting the surrounding areas in the coming months. Pacific Ridge is contracted with the Villa Park Landscape Company to ensure that the fuel modification areas are maintained twice per year, and per the OCFA specifications.



TRASH BIN REMINDER

Trash Bins should only to be placed out 24 hours before and after collection day. On the other days they are to be stored out of public view, behind your side gate, or in the enclosed garage. They are not to be stored in any location where they can be viewed from the sidewalk and/or street. Anyone to be found in violation of this rule will be subject to hearings and fines, per the Association's Enforcement & Fine Policy.

THEFT OF CATALYTIC CONVERTERS

Theft of catalytic converters. The entire county, not just Aliso Viejo has seen a substantial increase in this type of theft. The only real solution to not becoming a victim of this type of theft is to park your vehicles in your secured garage overnight. We realize that this might not be an option for some of you. Here are some suggestions:

- Keep your vehicle parked in a secure garage at night when possible. If the driveway is your best option, consider motion lights or a security camera covering the driveway, sidewalk, and street areas.
- In parking lots, choose spaces in well-lit areas, close to businesses or buildings.
- Get to know your immediate neighbors, and stay connected. Keep an eye out collectively for suspicious activity.
- Report suspicious activity to Sheriff's Dispatch at 949-770-6011.
